

AMENDMENT TO AGREEMENT

SWEETWATER UNION HIGH SCHOOL DISTRICT AND SOUTH BAY COMMUNITY SERVICES

Effective November 8, 2021, Sweetwater Union High School District (“SUHSD” or “District”) and South Bay Community Services (“SBCS” or “Consultant”) hereby amend their July 1, 2021 Memorandum of Understanding (“MOU”) to collaborate on the After School Safety and Enrichment for Teens (ASSETs) Program, a copy of which is attached hereto as **Exhibit 1**. This amendment is to reflect additional support services from an added funding stream to supplement the program. The parties incorporate the provisions of the Agreement as part of this Amendment as though fully set forth herein, excepted as modified herein.

The District and Company hereby agree to the following modifications of the Agreement:

2. Scope of Services, in addition to the previous language set forth in part 2, will include the following language:

“Having returned to in-person Before & After School Programs (BASP) programming at 14 Sweetwater Union High School District campuses, it is clear that additional resources and programming will be needed to navigate this transitional year successfully. SBCS, district’s BASP provider, is uniquely positioned as a city county, state, and federal contractor to help fill these needs directly from within our BASP teams. Schools have seen an increase in behavioral and psychological issues on campus stemming from any causes, including a recent lack of socialization, family and housing instability, and attendance stability due directly to COVID and the contact tracing that stems from the virus. The BASP staff will utilize SBCS’s unique programs to bolster mental health, family stabilization, behavior intervention and overall attendance.”

3. (A) Parties Responsibilities for Consultant, in addition to the previous language, will include the following language:

“Company will:

17. Provide enhanced training in Community Assessment Team, Children’s Mental Health and Here-Now skills and philosophies to allow for staff to more efficiently screen for service needs.

18. Enhanced collaboration with Community Assessment Team, Children’s Mental Health and Here-Now to allow for more efficient referral and onboarding.

19. SBCS staff will work collaboratively with school staff to refer directly into each mental health supporting program as needed when students show suicidal ideation during before and after school program.

20. Enhanced trainings for SBCS staff to better identify families who can benefit from our Community Services for families, First 5 First Steps and Proud Parenting programs.

21. Directly refer appropriate families to Community Services for families, First 5 First Steps and Proud Parenting programs.

22. SBCS Supervisors will be able to screen and refer families to SBCS Emergency Rental Assistance Programs throughout the school district's footprint and beyond through partner referrals.

23. Assist with after school participants in registering for and participating in COVID testing.

24. SBCS staff will support promotoras and partners with encouraging participation in study, encouraging weekly Communities Fighting COVID testing, (including assistance of delivering and use at home Communities Fighting COVID tests) and contact tracing and alignment of resources as needed for BASP students at middle school site in conjunction with SDSU study.

25. Service Navigation that will aid site supervisor's track and ensure referrals are landing in their appropriate departments efficiently."

4. Costs and Fees, shall include the following language to reflect the additional funding stream:

"i. In addition to fees in Exhibit A/B, District shall provide fee and cost, based on approved invoicing in the amount not to exceed \$71,107."

All other terms and conditions of the Agreement shall remain in full force and effect as stated in the originally signed agreement, dated July 1, 2021.
